Temp. Ord. A-68 (Finance)

An ordinance authorizing payment of the moral claim of Chris and Deborah James as approved by the Claims Commission, and declaring an emergency.

Miscellaneous Business:

Mr. James moved to excuse the absence of Mr. Mader, second by Mrs. Pyke. Motion passed, voice vote (10-0).

Mrs. Hummel stated that Council has received the Report 21. Other members, however, did not have it. Mr. Brodzinski stated he gave hard copies to Mrs. Hummel and to Mr. Rubino and e-mailed the report to the other council members. Mrs. Hummel stated that all members had requested hard copies the previous week. Mr. Brodzinski stated he would do that from this point forward. He then proceeded to give a budget update as of April 30, 2010. On the revenue side, Local Government Funds, which is based on consumer usage, is down \$45,000 compared to budget. The biggest hit is on estate inheritance tax, which is down \$263,000. The next supplement is in September and it could be down between \$350,000 to \$400,000 compared to previous years. Income Tax dollars are down \$7,000, but May is looking better. On the expenditure side, they look at all cost-cutting measures possible. Their job, as a city, is to provide the best resources to the citizens. Their job is not to be an employer of people. Leisure Time fund, overall, is up \$57,000 on revenue compared to 2009. It is up \$145,000 on the budget side across the entire fund.

Mr. James moved to adjourn, second by Mrs. Pyke. Motion passed, voice vote (10-0). Meeting adjourned at 8:10 p.m.
